ABOUT THE TAP PROGRAM

The TAP Certification Training provides 22 hours of credit toward NNAHRA's Tribal Human Resources Professional (THRP) I & II recertification.

The training is two-part certification program designed specifically for Indian Tribes and Tribal Organizations. This includes completion of online prerequisite course and in-person training. Open sessions are offered 3–4 times per year, and tribal organizations also have the option to contract with NNAHRA to host the training onsite at their location.

TWO-PART PROGRAM:

PART 1: ONLINE PREREQUISITE COURSE

- FOCUS ON ADJUDICATION CERTIFICATION AND ITS APPLICATION IN TRIBAL CONTEXTS

PART 2: IN-PERSON TRAINING

- 2.5 DAY IMMERSIVE PROGRAM, HANDS-ON LEARNING AND REAL-WORLD APPLICATION OF ADJUDICATION PRINCIPLES

The Tribal Adjudication Professional Certification sessions bring colleagues from various disciplines together to learn from one another and share practices for success.
